

# For Nepali Temporary Protected Status holders: How to prove your TPS and work authorization is automatically extended under Bhattarai v. Nielsen

Nepali TPS holders who properly re-registered for Temporary Protected Status, or TPS, during one of the last two re-registration periods or have a pending re-registration application have received an automatic extension of their TPS and related documents until March 24, 2020 under the Bhattarai v. Nielsen case.

Designation period	Re-registration dates
18-month extension: Dec. 25, 2016–June 24, 2018	Oct. 26, 2016–Dec. 27, 2016
12-month termination: June 25, 2018–June 24, 2019	May 22, 2018–July 23, 2018

### Proving your status at work

If you are an eligible Nepali TPS holder, you can show your employer you have an automatic extension of your TPS and work authorization until March 24, 2020 by presenting:

- The Federal Register Notice1 granting the automatic extension through March 24, 2020, and
- Your most recent Employment Authorization Document, or EAD, with category A-12 or C-19 and one of the following expiration dates: 6/24/2018 or 6/24/2019.

You do not need to apply for a new EAD in order to benefit from the automatic extension. For more information about the automatic extension of work authorization, read or show your employer the detailed instructions in the Federal Register Notice.

## Proving Your Status at the Department of Motor Vehicles, Other Public or Private Institutions, or to Law Enforcement

If you are an eligible Nepali TPS holder, you can use the documents listed below to show that you have an automatic extension of your TPS and EAD through March 24, 2020:

• A copy of the Federal Register Notice granting the automatic extension of work authorization

#### AND

- Your auto-extended EAD;
- A copy of your Form I-94 Arrival/Departure Record;
- Your Form I-797 Notice of Action Approval Notice; or
- Any other relevant Department of Homeland Security document that shows your immigration status or authorization to be in the U.S.

Some benefit-granting agencies use the Systematic Alien Verification for Entitlements Program, or SAVE, program to confirm the current immigration status of applicants for public benefits. For information about the SAVE program or for information on how to challenge the denial of a benefits application based solely on a SAVE response, see the Federal Register Notice.
