CBI Purpose and Goals

Purpose:

 To support organizations seeking to launch immigration legal services that are not yet authorized to provide them

Goals:

- To prepare organizations to apply for Department of Justice Recognition and Accreditation
- To prepare organizations to join CLINIC as Affiliates

Eligibility Requirements

Must have held 501(c)(3) nonprofit status for at least six months

Cannot have a pending DOJ R&A application

Must have an identified candidate for DOJ

Accreditation

Must not be engaging in the unauthorized practice of immigration law

Must have community partnerships to provide required supervision for DOJ R&A application process

Application Process

Fill out an application by the June 14th deadline

Provide proof of 501(c)(3) status for at least six months

Notification of acceptance will be sent out by **July 1**

Organizations must register and pay fees in full by **July**12

Fees start at **\$3,250**

Joining CLINIC



Upon successful completion of the CBI, Participants will be invited to apply to join CLINIC as an Affiliate



Applications are reviewed on a case-by-case basis, **and** affiliation is not guaranteed



The letter of Technical Legal Support for the DOJ R&A application will only be provided to organizations who are approved for CLINIC affiliation



If approved, fees for the CBI will include affiliate dues for the remainder of **2026**

CLINIC seeks affiliates that:

Have a **demonstrated mission** to serve low-income and other vulnerable immigrants.

Are providing direct legal services to low-income immigrants in an authorized manner.

Have community partnerships already established.

Understand the responsibility involved in opening a legal services program.

Develop a long-term strategy to offer legal services to immigrants.

CLINIC seeks affiliates that could meet the following characteristics:

- Has had 501c3 status for at least 12 months
- Can provide proof that offering immigration legal services matches the organization's mission
- Is financially sound and can provide current, audited financial statements
- Has a board of directors' resolution approving CLINIC affiliation
- Has a community partner's letter of recommendation
- Does not have a pending DOJ office recognition application

Features of a strong ILS program

Authorized to offer legal services

Legal services are only offered if agency is authorized

Community partners and community support

Short-term and a long-term plan for growth and sustainability

Protects clients' confidentiality

Referral plan in place

Defined scope of service
