The designation was set to expire on Aug. 3, 2025, a result of Sec. Noem issuing a partial vacatur of the July 2024 decision previously issued by the Biden administration to extend TPS for Haiti until Feb. 3, 2026.</p> <p>However, also on July 1, 2025, a federal judge made a ruling that reinstated the February 2026 termination date. The government will likely appeal this decision. CLINIC will continue to monitor and provide updates.</p>	Termination effective as of Feb. 3, 2026	90 FR 28760
