INFORMATION ON TESTIFYING IN IMMIGRATION COURT

- You will be under oath so be sure to tell the truth.
- If you are asked a question that you do not understand, state that you do not understand the question.
- If you are asked a question that you do not know the answer to, state that you do not know the answer. DO NOT guess at what the answer might be.
- Listen to the complete question before answer. If there is an objection by an attorney to the question, wait for the judge to tell you whether to answer or not. You will know an objection has been made because either the DHS attorney or I will say "objection."
- If you are using an interpreter, wait for the interpreter to state the whole question, and then answer only in your native language. Do this even if you understand the question in English.
- Please review your declaration (if any). If there is anything that is not accurate, please let me know right away. The Immigration Judge and the opposing attorney could ask you questions about the contents of your declaration/letter. You are NOT permitted to have a copy of your declaration with you when you testify.
