To apply for a USCIS Fee Waiver please provide:

Means Tested Benefit: Proof of the benefit that you or an immediate family member (spouse or child) are currently receiving. This evidence must be in the form of a letter, notice or other official document containing:

- Granting agency's name
- Recipient's name
- · Name of the benefit
- Date you started to receive the benefit
- If you are applying because of an immediate family member please provide a government form demonstrating the relation (marriage certificate, birth certificate)

Please provide the most recent letter in **ENGLISH**

*You may qualify for a fee waiver based on household income. Please call our office for details. Additional fees apply.

To complete your Application for Naturalization you must bring the following information and documents:

- □ Your Legal Permanent Resident card "green card", State Identification or Driver License card, Social Security card and any passports you have been issued since you became a Legal Permanent Resident.
- ☐ Your address and job history for the last 5 years
- ☐ If you or your current husband/wife have had previous marriages, bring your marriage and divorce certificates for all marriages.
- ☐ If you have ever been arrested, certificates of disposition for all arrests.
- ☐ All trips taken outside the United States for the last 5 years.
- Money order for \$680 payable to the "US Department of Homeland Security" or documents for Fee Waiver applications (see below)
