Batalla Vidal Order

- Dec. 4, 2020 court order re-opening DACA program on its terms prior to the first Trump administration termination attempt, on Sept. 5, 2017.
- · First-time initial applications being accepted
- Advance Parole under 2012 standards
- Renewals of DACA and EADs for 2 years
- · Applies to nationwide class



DHS Response

- · So far, DHS is complying with the Court order
- Please note any issues with compliance for us via dacaclassaction.org or via email
- Individualized notice to various sets of class members by Jan. 8, 2021
- New 2-year EADs at no cost to DACA recipients
- Data report to court due Jan. 4, 2021

 intervenors in this case, follow them for
 updates.

DACA Eligibility Requirements

- Must be at least 15 years or older to request DACA
 - unless you are currently in removal proceedings or have a final removal or voluntary departure order
- Under 31 years old on June 15, 2012
- Came to U.S. prior to age 16
- Continuous residence in U.S. since June 15, 2007
- No lawful status and physical presence in the U.S. on June 15, 2012 and on date of application

DACA Eligibility Requirements

- Currently in school; obtained a H.S. diploma or GED; or honorably discharged from the U.S. armed forces
- Not convicted of a felony; a significant misdemeanor; or 3 or more non-significant misdemeanors; or otherwise pose a threat to national security or public safety
 - USCIS has discretion to grant DACA under "exceptional circumstances"

How would you advise Jackie?

Jackie came to the U.S. in 2005 when she was 10 years old. She had not met the DACA education requirement before the program was terminated in 2017. She now wants to apply for DACA for the first time but is nervous, especially since she lives with undocumented parents. She wants to know:

- Should she file now or wait, maybe until after Biden is in office?
- Can she travel to visit family abroad?

Advance Parole

- · Must be granted DACA prior to applying
- Must be for approved purposes:
 - Humanitarian
 - Educational
 - Employment
- · May request expedite or emergency AP
- DACA recipient should return before AP and DACA grant expire



Other Practice Tips

- Counsel clients about risks and benefits before filing
- File initial applications without delay
- Screen for other relief, including relief from removal
- Consider how you will help clients gather evidence remotely
- · Carefully complete forms to avoid RFEs

Program Management Tips on DACA Service Delivery

- Consider remote legal service delivery and virtual workshops https://www.newamericanscampaign.org/wp-content/uploads/2020/10/Comprehensive-Guide-to-Remote-Citizenship-Services_Final.pdf
- Use your case management database to its fullest capacity in reporting, prioritizing, and organizing
- · Track consultations that don't lead to applications
- Make sure that all your DACA applicants, past clients, update their current addresses with USCIS

Other Program Management Considerations

- Have a realistic assessment of how many cases you can take and manage client expectations
- Build capacity by getting accreditation for your volunteers and staff - https://cliniclegal.org/toolkits/recognition-accreditation
- Update fee schedules and policies, and standardize training manuals for remote training and supervision https://cliniclegal.org/toolkits/case-management
- Advocate for your agency's immigration program needs to your leadership and funders

Dec. 9, 2020 Federal Register Notice

- Automatically extends I-797 approval notices, I-94s, and EADs through Oct. 4, 2021
- Must have properly re-registered during a prior registration period (or have pending re-registration app.) and have (a)(12) or (c)(19) EAD with expiration date of:

7/22/17	11/2/17	1/5/18	1/22/18	3/9/18	6/24/18
7/5/18	11/2/18	1/5/19	4/2/19	6/24/19	7/22/19
9/9/19	1/2/20	1/5/20	3/24/20	1/4/21

Dec. 9, 2020 Federal Register Notice

- Eligible TPS holders do not need to pay a fee or file any application
- May still file late re-registration application if can demonstrate "good cause"
 - https://cliniclegal.org/resources/humanitarianrelief/faqs-late-re-registration-tps
- Auto-extension does not apply to TPS holders whose status has been withdrawn or denied

Timeline for Terminations

- Once all appeals exhausted (and assuming the government prevails), the following wind-down periods apply:
 - Honduras, Nepal, Nicaragua, Sudan: 120 days from issuance of appellate mandate to *Ramos* district court
 - Haiti: 120 days from issuance of the later of the two appellate mandates (*Ramos* and *Saget*)
 - El Salvador: 365 days from issuance of appellate mandate to *Ramos* district court
