# IMMIGRANT INTEGRATION FUNDING GUIDE

### **Immigrant Integration and Funding Opportunities**

Immigrant integration is an equal partnership between newcomers and the receiving community who work together to make their community more inclusive. As trusted members in the community, immigration legal service providers play a key role in promoting integration. Nonprofits that engage in integration efforts in addition to legal services increase capacity, expand their services, work with all members in the community, and thus, have an increase in opportunities to additional/alternate funding streams.

For many charitable-based immigration legal services, obtaining consistent funding is crucial to providing legal services to the immigrant community. Despite its importance, immigration law is complex, causing it to be too narrow of a focus for some funders. Nonetheless, immigration service providers can expand their focus through the integration projects and initiatives that benefit immigrants and the wider community.

For example, immigration benefits are often accompanied by work authorization. A funder may be less interested in immigration but very supportive of anti-poverty, ready-to-work programs — especially for limited English proficient people entering the workforce. Similarly, a funder may not know about the immigration provisions of the Violence Against Women Act, or VAWA, but would be willing to fund the legal work knowing it enables survivors to make decisions more freely and safely for their futures and those of their children — thus breaking the cycle of violence.

When researching and establishing partnerships with funders and foundations, it is important to ensure that your organization's missions and values align with the mission and values of the funder. In addition to meeting the basic eligibility for grant opportunities, an organization should have a strong proposal, clear project goals and objectives, and systems in place for measurement and evaluation. This guide offers helpful grant websites, resources, and tips as your organization prepares to promote immigrant integration and apply for funding.

# Integration-Specific Grant Websites

- U.S. Citizenship and Immigration Services The Citizenship and Integration Grant Program funds organizations that work with lawful permanent residents prepare for their U.S. citizenship.
- Russell Sage Foundation In addition to prioritizing race and inequality issues, the Russell Sage Foundation supports research on immigration and immigrant integration.
- Charles Koch Foundation From criminal justice to education to immigration, the Charles Koch Foundation funds general proposals from organizations that share their goals and vision "of removing barriers that prevent communities from reaching their full potential."

- Candid Select the "Find Funding information." Once there, you can search the foundation directory online by using searching a specific funder or an organization location. Feel free to browse the other tools offered by Candid.
- Grants. Gov Website for federal grants. Making an account is free and their search engine allows you to filter criteria. For example, you can search by agency, eligibility, funding type and category.
- Catholic Funding Guide A network of over 2,000 funders that have a history of supporting various issues, such as education and social services. There is an annual fee of \$145 for the year in order to gain access to the guide.
- W.K. Kellogg Foundation Priorities are thriving children; working families; and equitable communities.
- Public Welfare Foundation Investing in nonprofits that are advancing a new, transformative system of justice with the core values of racial equity, economic well-being and fundamental fairness for all.
- Catholic Campaign for Human Development CCHD has three grant programs: the Community Development Grant, Economic Development Grant and the Strategic National Grant. The grant opportunities support efforts that demonstrate a commitment to the dignity of the human person.
