  - o \$410 for re-registration applicants younger than 14 (*work authorization included*)
  - 5 \$495 for re-registration applicants 14 and older (work authorization included)
  - \$85 for re-registration applicants 14 and older who DO NOT want work authorization
  - \$0 for re-registration applicants younger than 14 who DO NOT want work authorization
  - OR IF UNABLE TO PAY THE FEE, FORM I-912 WITH SUPPORTING DOCUMENTATION (include only <u>one</u> of the below reasons for inability to pay)
    - Proof of income at or under 150% of the federal poverty guidelines

(tax returns best evidence of this) OR;

- Receipt of a means tested benefit (Medicaid, SNAP, TANF, and SSI.
   Includes federally funded, state funded, and locally funded programs)

- Financial hardship (medical expenses, financial hardship, homelessness, eviction)
- <u>Proof of TPS Status</u> (include at least <u>one</u> of the below items)
   Photocopy of TPS Approval Notice Form I-797, Employment Authorization Document (EAD)
- If applicable, Form I-601, Application for Waiver of Grounds of Inadmissibility and supporting documentation
- If applicable, certified court disposition related to any criminal arrest, charge, or conviction

## **NOTES TO PRACTITIONER:**

- Generally, re-registration applicants do not need to submit copies of any documentation to demonstrate eligibility but practitioners may want to include at least one supporting document to show the applicant's continuous residence since they were initially granted TPS.
  - Examples include employment records, pay stubs, IRS printout of Federal income tax returns, rent receipts, utility bills, school records, medical records, attestation from church/religious institution, birth certificates of children born in the United States, dated bank transactions, insurance policies, and vehicle registration.
- Those submitting first-time re-registrations with USCIS after an Immigration Judge or the Board of Immigration Appeals has granted TPS should include a copy of that decision with their Form I-821.
