### Background on DOJ R & A

- The DOJ Recognition and Accreditation Program allows non-attorneys at nonprofit organizations to provide immigration legal services
- Identified the requirement for hands-on experience as the primary barrier to obtaining staff accreditation
- Want to remove barrier and provide a solid foundation for aspiring accredited representatives

### **Objectives**

- Advancing the justice mission of the Recognition and Accreditation Program through robust training and mentorship
- Provide mentees with access to a mentor to gain practice skills (interviewing, intake, reviewing documents, legal research, how to process cases)
- Mentees obtain technical assistance in applying for DOJ Recognition and Accreditation
- Mentees will become DOJ Accredited Representatives.

### Objectives (cont'd)

- Solicit input from mentors and mentees on how to further remove barriers to building immigration legal service capacity throughout Minnesota.
- Create partnerships among nonprofit immigration legal service providers
- Increase the number of qualified applicants for DOJ accreditation in Minnesota, leading to more robust access to affordable immigration legal representation.

### **Eligibility Requirement for Mentees**

- Must be an employee or volunteer at a nonprofit organization
- Must have agency approval and support
- Must be in Minnesota
- Must be committed to taking the training, participating in the virtual/remote mentorship opportunities and applying for accreditation (and recognition if the organization is not recognized)
- Main objective must be to become authorized to practice immigration law and provide immigration legal services

### **Eligibility Requirement for Mentors**

- Be an accredited representative or immigration attorney (employee or volunteer) at a nonprofit immigration legal services program
- Prefer mentor be in Minnesota but will consider neighboring states
- Have a minimum of three years of experience as an accredited rep or immigration attorney
- · Commitment to provide virtual/in person shadowing experience and mentorship
- $\bullet$  \*Will consider private immigration attorneys who are well connected with nonprofit immigration legal service organizations
